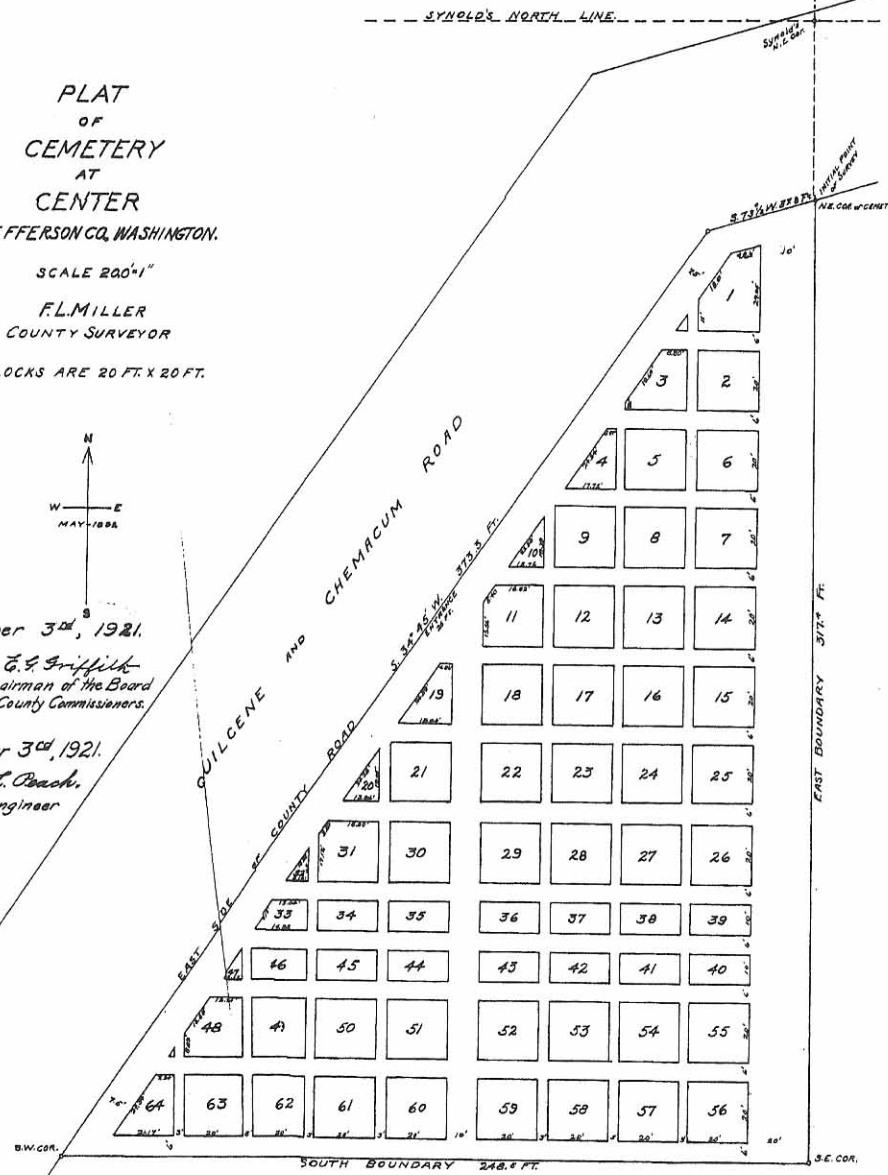

DESCRIPTION

"Beginning at a point North as the initial point of this description, said point being on the Southern side of the Quilcene and Chimacum Co. road and also on the East boundary of Ernest Synold land and distant 1200.± feet North of the Quarter Section post on the Sixth boundary of Sec. 3, Tn. 28 N., R. 1 W., W.M., and South 89.± ft. from the North East corner of said E. Synold land; thence along the Southern side of said Co. road S. 73° 30' W. 378 feet; thence S. 34° 45' W. 373.± feet to the South West corner of this tract; thence due East 248.± feet to the South East corner; thence due North 317.± feet to the place of beginning containing 1 acre, more or less."
